

**ORDINANCE NO. 202 2 -30E**

**AN ORDINANCE OF THE CITY OF SNOOK, TEXAS, ADOPTING THE INTERNATIONAL BUILDING CODE 2018 EDITION; ADOPTING LOCAL AMENDMENTS TO THE INTERNATIONAL BUILDING CODE; PROVIDING FOR A REPEALER CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Snook (hereinafter “City”) is a General Law municipality; and

**WHEREAS**, pursuant to the laws of the State of Texas, including Texas Local Government Code section 51.001, the City Council of the City of Snook has the authority to adopt, publish, amend or repeal an ordinance that is for the good government, peace or order of the City; and

**WHEREAS**, Section 214.216, Texas Local Government Code, specifically authorizes the City to adopt local amendments to the *International Building Code*; and

**WHEREAS**, the City Council is of the opinion and finds that the adoption of the *International Building Code* 2018 Edition and local amendments to said *International Building Code* will promote the public health, safety, and general welfare, and will promote the best and most orderly development of the properties affected thereby, and to be affected thereby, in the City, and as well, the owners and occupants thereof, and the City generally;

**NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Snook, Texas that:**

**I. ADOPTION OF CODE**

**International Building Code**

**Sec. 1.01 Adopted**

A certain document, one copy of which is on file in the office of the city secretary, being marked and designated as the *International Building Code*, 2018 edition, including appendix chapters C – N (excluding A, B, & H) and any amendments that become an official part of said code, as published by the International Code Council, be and is hereby adopted as the building code of the City, for regulating and governing the conditions and maintenance of all property, buildings and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use and the demolition of such structures as herein provided; providing for the issuance of permits and collection of fees therefore; and each and all of the regulations, provisions, penalties, conditions and terms of said building code on file in the office of the City are hereby referred to, adopted, and made a part hereof, as if fully set out in this section, with the additions, insertions, deletions and charges, if any, prescribed in section 1.02 of this Ordinance.

**Sec. 1.02 Local Amendments**

The following sections are hereby revised:

Section 101.1. Insert: City of Snook.

Section 109.2. Substitute: On buildings, structures, electrical, gas, mechanical and plumbing systems or alterations requiring a permit, a fee for each permit shall be paid as required, in accordance with the schedule as established by the applicable governing authority and on file in the office of the city secretary of the City of Snook.

Section 114.2 Delete section item.

Section 114.4. Substitute: Violation Penalties: Any person who shall violate a provision of this code or shall fail to comply with any of the requirements thereof or who erects, constructs, alters or repairs a building or structure in violation of the approved construction documents or directive of the code official, or of a permit or certificate issued under the provisions of this code, shall be guilty of a misdemeanor, punishable by a fine of not less than \$25.00 nor more than \$1,000.00. Each day that a violation continues after due notice has been served shall be deemed a separate offense.

**Sec. 1.03 Payment of permit fees**

A permit shall not be issued until the fees which are on file in the city secretary's office have been paid. No amendment to a permit shall be approved until the additional fee, if any, due to an increase in the estimated cost of the installation, shall have been paid.

**Sec. 1.04 Failure to obtain permit**

If any person commences any work for which a building permit is required before obtaining the necessary permit from the City, he shall be subject to the penalty prescribed in the *International Building Code*.

#### **Sec. 1.05 Ordinance Control**

The requirements of this Ordinance shall control should they conflict with the *International Building Code* as adopted by the City.

### **II. REPEALER**

All provisions of the ordinances of the City of Snook in conflict with the provisions of this Ordinance are hereby repealed, and all other provisions of the ordinances of the City of Snook, not in conflict with the provisions of this Ordinance, shall remain in full force and effect. The repeal of any ordinance or part of ordinances effectuated by the enactment of this Ordinance shall not be construed as abandoning any action now pending under or by virtue of such ordinance or as discontinuing, abating, modifying or altering any penalty accruing or to accrue, or as affecting any rights of the municipality under any section or provisions of any ordinance at the time of passage of this Ordinance.


### **III. SEVERABILITY**
